GHG is the single largest market participant, accounting for 24% of total hospital bed capacity in the country, as of 30 September 2019. GHG is also the largest pharmaceuticals retailer and wholesaler in Georgia, with approximately 32% market share by revenue and the largest provider of medical insurance in Georgia with a 32% market share based on net insurance premiums earned and approximately c.230,000 insurance customers. GHG employed a total of c.16,100 people as at 30 September 2019, including c.3,400 physicians and 3,000 pharmacists.
