#### About Georgia Healthcare Group PLC

Georgia Healthcare Group PLC is a UK incorporated holding company of the largest healthcare services provider in the fast-growing, predominantly privately-owned, Georgian healthcare services market. GHG's leadership position is underpinned by offering the most comprehensive range of inpatient and outpatient services targeting the mass market segment through its vertically integrated network of 35 hospitals and ten Polyclinic clusters (consisting of 13 district Polyclinics and 24 express outpatient clinics), as at 30 June 2017. GHG is the single largest market participant, accounting for 24.6% of total hospital bed capacity in the country, as of 30 June 2017. From January 2017, GHG became the largest pharmaceuticals retailer and wholesaler in Georgia, with approximately 29% market share based on 31 December 2015 revenue figures. GHG is the second largest provider of medical insurance in Georgia with a 30.9% market share based on net insurance premiums earned and approximately 135,000 insurance customers as at 30 June 2017. GHG employed a total of c.14,800 people as at 30 June 2017, including c.3,400 physicians.
