GHG’s leadership position is underpinned by offering the most comprehensive range of inpatient and outpatient services targeting the mass market segment through its vertically integrated network of 35 hospitals and six ambulatory clusters (consisting of nine district ambulatory clinics and 28 express ambulatory clinics), as at 30 June 2016. GHG is the single largest market participant, accounting for 25.1% of total hospital bed capacity in the country, as of 30 June 2016. GHG is the third largest pharmaceuticals retailer and wholesaler in Georgia, approximately 15% market share by revenue, as of 31 December 2015.
